



Privacy Policy – Guest Consent for Data Processing by VITWI

1. Data Controller

2. Data Collected

During your stay, the host may record and share the following data on VITWI:

- ✓ Full name
- ✓ Phone number
- ✓ Address, country, city
- ✓ ID document or passport
- ✓ Nationality
- ✓ Date of birth
- ✓ Email
- ✓ Platform
- ✓ Information related to the stay (dates, duration, number of guests)
- ✓ Internal ratings and relevant observations about your behavior as a guest (e.g., rule compliance, cleanliness, punctuality, etc.)

Note: This information is not published publicly or indexed by search engines.

3. Purpose of Processing

The purposes of the data processing are:

- ✓ To facilitate a private trust network among hosts by sharing internal guest reviews.
- ✓ To prevent incidents and improve the quality of stays.
- ✓ To comply with legal obligations, where applicable.

4. Legal Basis for Processing

The legal basis for processing your data is:

- ✓ Your explicit consent by signing this privacy policy.
- ✓ The legitimate interest of hosts and VITWI in preventing fraud, harm, or negative experiences and improving the hosting experience.

5. Data Sharing

Data will not be shared publicly or with unauthorized third parties. It will only be visible privately and in a limited way to registered and verified hosts on the VITWI platform, within the scope of their activity as hosts.

The data that will be privately shown to registered and verified hosts includes your name, nationality, rating, date of birth, and platform.

Internal searches on VITWI will use the phone number, but this will only be used to locate information and will not be displayed in the results.

Your data will not be sold or used for commercial or advertising purposes.

6. Data Retention

Your data will be retained for a maximum of 3 years unless you exercise your rights earlier or a longer retention period is required by law.

7. Guest Rights

You may exercise the following rights:

- ✓ Access your data
- ✓ Rectify or update your data
- ✓ Delete your data
- ✓ Object to or limit the processing of your data
